4) <b>Lawful basis</b> for processing	The sharing is to support Direct Care which is covered under  Article 6(1)(e); "necessary in the exercise of official authority vested in the controller' and  Article 9(2)(h) 'necessary for the purposes of preventative or occupational medicine for the assessment of the working capacity of the employee, medical diagnosis, the provision of health or social care or treatment or the management of health or social care systems and services"  We will also recognise your rights established under UK case law collectively known as the "Common Law Duty of Confidentiality"*
5) Recipient or categories of recipients of the shared data	The data will be shared with the designated Providers of the screening services for this particular geographic area.

6) Rights to object	You have the right to object to this processing of your data and to some or all of the information being shared with the recipients. Contact the Data Controller or the practice. For national screening programmes: you can opt so that you no longer receive an invitation to a screening programme.
